



Event Information: This is a fun (not timed) race, and is available to anyone. Children ages 0-5 participate with a PARENT for free. Elementary students (K-5) must also be accompanied by a PARENT. **All proceeds benefit the Otsego County Demonstration Gardens and Conservation Forest.**

Date, Time, Location: This run will be held Saturday, June 24th at 10am. Location is the Otsego Conservation District Education Center, 459 Livingston Blvd., Gaylord MI.

Registration Options:

Packet Pick-up: Race registration packets may be picked up on race day starting at 9am at the race site (Education Center).

Entry Fee: Early entry deadline, May 31: \$20 per participant (guarantees T-Shirt). Registration after May 31 and day of race: \$25 (does not guarantee T-Shirt).

Course Description: Race will be a cross country 5K that will be partly on grass, partly on paved drives, including some hills. Not appropriate for strollers that are not all-terrain. The course will travel through the beautiful Demonstration Gardens which will be in full bloom. It will also follow trails through the tall trees and shade of the Conservation Forest.

Parking: All participants must park in the overnight parking area for the Alpine Center.
